



CITY OF COCONUT CREEK

Butterfly Capital Of The World



Coconut Creek, the "Butterfly Capital of the World," is a well-planned city with a unique environmental consciousness nestled between Miami and Palm Beach. It is home to the world's largest butterfly aviary a zoo, of sorts, for butterflies. The City is widely recognized as a progressive community that touts an abundance of trees, waterways, attractive landscaped roads, beautiful parks, and butterfly gardens throughout its neighborhoods. Coconut Creek is the first in the State of Florida and eleventh in the country to be certified as a Community Wildlife Habitat. In 2017, it received the Tree City USA Growth Award from the Arbor Day Foundation and re-certification for

the Sustainable Communities Program from Audubon International.

Spotlighted as one of the "Best Cities to Live in America" by Money Magazine, and a "Top Ten Place to Live" in Florida by Movoto and NerdWallet, Coconut Creek is home to 59,000 residents. Residents enjoy exceptional outdoor activities such as movies and concerts in the park, as well as the Butterfly Festival and 5K Butterfly Run, which are annual traditions. In a 2016 residential survey, 97% rated Coconut Creek as an "Excellent" or "Good" place to raise a family and 99% rated the overall quality of life in Coconut Creek as "Excellent" or "Good."

The City also supports a diverse and growing business community. The City's Mainstreet Project, home to the Seminole Casino Coconut Creek and the Coconut Creek Promenade, a 23acre upscale shopping and restaurant center, has received the "Award of Excellence" for its Design Standards by the Florida Chapter of the American Planning Association (FAPA). When complete, the City's MainStreet area will be bustling with over 250 acres of businesses, upscale housing, and beautifully landscaped parks and greenways; all requiring green certified construction. Amazingly, this area is geographically centered in the City and will act as a focal point for future growth. It will showcase a pedestrian -oriented, mixed-use community, organized around substantial, centralized and contiguous recreational open space and alternative transportation options.


The City has worked hard to create a pedestrian-friendly Master Plan for Coconut Creek Parkway, which is also known as the Education Corridor. It serves as a park-like corridor that includes benches, bus pavilions, landscaping and a 15' wide lighted bicycle and pedestrian path. Thousands of students attending Broward College, Atlantic Technical College, and Coconut Creek High School enjoy this welcoming strip.

CITY OF COOPER CITY Someplace Special



Cooper City is a beautiful residential city, well-loved by residents and non-residents alike. Not long ago, Family Circle magazine named it one of the 10 best places to raise a family. Abundant with parks, an excellent school system, and a welcoming community, it is a perfect environment for families to work and play.

Cooper City's schools, which are all A-rated, are a big attraction for new residents. Cooper City High School is nationally acclaimed as a Blue Ribbon School and one of America's Best High Schools by The Washington Post and Newsweek. Of the schools located in the city, all the elementary and middle schools are ranked in the top 15% in Florida by schooldigger.com. Residents are extremely proud of their close-knit community. The neighborhoods are friendly and the residents support each other. People and institutions work together for the betterment of the City.

Founder Morris Cooper envisioned a well-planned community of former orange groves and cattle grazing land reclaimed from the Everglades. Cooper purchased the land after it was devastated by floods in 1947. By 1959, Morris Cooper's development housed 85 residents. That same year, a Special Act of the Florida legislature created Cooper City. With the annexation and development of the former Waldrep Dairy property – now Monterra, Cooper City has grown to a town encompassing approximately seven square miles with more than 33,000 residents.

The City follows the Commission-Manager form of government with a mayor and four commissioners serving staggered four-year terms, with term limits of three consecutive terms. The commissioners are dedicated to doing what is best for the community and they hold the staff in high regard. City employees are talented and wear many hats. They pride themselves on being accessible to residents and on working hard to solve their problems.

The City is in good financial health, financially conservative and reserves are sufficient. The total budget is \$57.3 million with the General Fund portion being \$35.6 million. Throughout the years, the focus of city leaders has been to provide necessary services to a rapidly expanding community while preserving the special place Cooper City has become.

Cooper City has earned the reputation of being called "Someplace Special". Cooper City is proud of its strong sense of community, excellent park and recreational facilities and exceptional schools. Our mission is to provide excellent services and facilities to support a high quality of life for our residents.

One measure that sets Coral Springs apart is our attention to fiscal responsibility. Both Fitch Ratings and Standard and Poor's have re-affirmed the City's AAA rating, a recognition from the market that saves our community millions of dollars.

Our Coral Springs Police were recently reaccredited "with Excellence" in the areas of law enforcement and communications. Our fire department earned a Class 1 rating by the Insurance Services Office; they are among only 24 in this class in the State of Florida. Our residents can rest assured that officers, firefighters, as well as all city staff, are always doing their best to keep everyone safe. Our Economic Development Office is leading the business retention and expansion efforts in the City of Coral Springs, assisting local businesses to stay and grow here, and supporting issues that enhance our area's economic competitiveness. The EDO has all the necessary resources to work with any size business. In 2016, the Economic Development Office retained 1,520 jobs and helped create 1,093 new positions in Coral Springs.

In addition, the City's new 74,000 square-foot Municipal Complex has opened its doors. It houses City Hall, the Community Redevelopment Agency and the Coral Springs Regional Chamber of Commerce, along with offices for elected officials to meet with their constituents. A 607-space parking garage serves both municipal and commercial purposes. The project is expected to trigger more redevelopment.

Last but not least, we value open dialogue with our residents and businesses and are always exploring new ways to engage our community – from emerging trends in social media to publications. The City of Coral Springs prides itself on customerfocused government and providing quality services to our residents.

CITY OF DANIA BEACH Sea It, Live It, Love it



The City of Dania Beach was incorporated in 1904 as Broward's first city. The City is located immediately south of the Fort Lauderdale-Hollywood International Airport, Port Everglades, and the Broward County Convention Center.

Dania Beach is a major player in South Florida's academic, marine, and tourism industries. The American Maritime Officer's Simulation, Training, Assessment and Research Center, with state-of-the-art bridge and engine room simulators, offers advanced merchant marine training.

The City's 120 slip marina, located between the Intracoastal and the Atlantic Ocean, Bass Pro Shops and Diver's Direct are major attractions for people interested in outdoor sports, boating, and fishing.

SeaTech, FAU's Institute for Ocean and Systems Engineering is the na-

tion's first ocean engineering program. The world-class faculty is engaged in research and technology development in the areas of acoustics, marine vehicles, hydrodynamics and physical oceanography, marine materials, and nanocomposites.

The City's recreation program includes a beach and fishing pier, pools, tennis courts, neighborhood parks and community centers that provide a wide variety of programs for youth, adults and senior citizens.

Dania Beach has earned its Leadership in Energy and Environmental Design (LEED) Gold certification from the US Green Building Council, the nation's lead governing body on sustainable design. The Dania Beach Nanofiltration Water Treatment Plant is the first LEED Gold Certified Water Plant in the world. The Dania Beach-Paul DeMaio Library building also achieved LEED Gold certification. Dania Pointe will soon make Dania Beach Broward County's preeminent lifestyle destination. The mixed-use development has close to 1 million square feet of retail, restaurants, Class A offices, hotels, luxury apartments and public event space.

Dania Beach has implemented Oasis - Rebuilding Neighborhoods, an innovative community project that is improving the city one street at a time. The goal is to foster neighborhood pride and improvement, and through a "ripple effect" induce owners and tenants in the City to work together to beautify the City, increase property values and reduce crime.

The Dania Beach Casino features 900 Las Vegas-style slot machines, a 24-table card room, nationallyknown artists and live Jai-Alai. Grampa's Bakery, Jaxson's Ice Cream Parlor & Restaurant, Quarterdeck, Rustic Inn Crabhouse and Tarks are some of our local favorites.

The DCOTA Design Center, The Wiener Museum of Decorative Arts, The Gallery of Amazing Things and The Holocaust Documentation & Education Center bring visitors from all over the world right to the heart of our beautiful city.

The Town of Davie prides itself on being the place to live, work, learn and play. Davie is one of the largest municipalities, spanning 36 square miles with a population of over 101,000 permanent residents. The Town's economic development priorities include diversifying the tax base, enhancing the guality of life and promoting sustainable growth. The Town's development focus is its two redevelopment areas, the Regional Activity Center (RAC) and the Transit-Oriented Corridor (TOC). The RAC is designed to accommodate large-scale development and includes 853 acres of land zoned for research and development and more than 1,300 acres zoned for educational, commercial, industrial and residential uses. The TOC accommodates a wide range of uses that promote interaction with the Fort Lauderdale-Hollywood International Airport and Port Everglades.

The Town is home to the Miami Dolphins Training Facility located on the Nova Southeastern University Campus, and the Bergeron Rodeo Grounds. The Rodeo Grounds have been a main attraction for Davie residents and visitors for over 40 vears. The Town annually hosts the Southeastern Circuit Pro Rodeo Finals, the largest rodeo east of the Mississippi River. Originally established for rodeos, this venue now holds events such as concerts, monster truck shows, horse shows, dog shows, car shows, airboat shows specialty shows, and industrial shows.

The Town of Davie is the nexus of higher education in South Florida where several nationally known colleges, technical institutes, and universities make up the South Florida Educational Center (SFEC). Nova Southeastern University, Broward College, University of Florida, Florida Atlantic University, McFatter Technical/Vocational School and several Broward County Public School facilities make up the SFEC. The proximity of these institutions creates a synergy unlike any other place in the United States.

CITY OF HALLANDALE BEACH

Hallandale Beach is a city in Broward County, Florida, United States. The City is named after Luther Halland, the son of a Swedish worker for Henry Flagler's Florida East Coast Railroad. As of the 2010 census, the population was 37,113.

The area was settled in the late 1800s as a farming community in Dade County. When Broward County was created, Hallandale became part of the new county. Hallandale was incorporated as a town on May 14, 1927. By that time, there were 1,500 residents, street lights, and electricity in the community. In August of 1999, the City officially changed its name to Hallandale Beach. Our City is a full-service City that provides various services including Police, fire, parks, public works, code enforcement, building and planning services.

Hallandale Beach parks offer lush tropical scenery, public athletic facilities, playgrounds, community centers, and a world-class beach. From bocce courts to the historic village, there's something for everyone at the parks in Hallandale Beach! We are very proud to have two beachfront parks and currently have a private public partnership agreement with Etaru restaurant at our North City Beach Park facility.

The City is known as the home of Gulfstream Park (horse racing and casino) and Mardi Gras Casino, a greyhound racing track which hosts the World Classic. It also has a sizable financial district, with offices for a number of banks and brokerage houses. Due to the large number of tourists who eventually retire in the City, Hallandale Beach has one of the fastest-growing populations in Broward County and in Metro Miami.

Hallandale Beach is conveniently located between Fort Lauderdale and Miami, next to Aventura with access to the Fort Lauderdale/ Hollywood and Miami International airports, Port Everglades, Port of Miami, and I-95. Visitors, as well as residents, enjoy beautiful beaches, exciting pari-mutual wagering, and comfortable hotels. Hallandale Beach offers a wide choice of sporting activities year round including tennis, golf, swimming, boating and salt water fishing. Evenings offer a choice of fine or casual dining and nightclub entertainment for all ages and outdoor fun. Merchandise of every kind can be found in shopping centers, individual boutiques and malls, conveniently located throughout the city.

TOWN OF HILLSBORO BEACH Florida's Magnificent Mile



The Town of Hillsboro Beach is beautifully situated on a narrow peninsula between the shimmering Intracoastal Waterway and the clear blue Atlantic Ocean. The Town's southern boundary is punctuated by the Hillsboro Inlet and the majestic and historic Hillsboro Lighthouse. The town's total length is about 3 miles and at its widest part is only about 900 feet.

The Hillsboro Lighthouse is one of the Town's most prominent attractions. As early as 1855 this portion of the Atlantic Ocean was designated as being hazardous for the safe navigation of shipping, and the Federal government was requested to fund a lighthouse to provide the necessary warnings to mariners. This request, however, was rejected 17 times over the years, and took an additional 46 years before the Federal government in 1901 finally agreed to provide \$90,000 to build a "firstorder light at or near Hillsboro Point." After various construction delays and with major components of the lighthouse coming from such diverse locations as Detroit, Michigan and Paris, France, the lighthouse was finally put into service in 1907. This structure marks the northern end of the Florida Reef and extends 138 feet skyward. It is capped with a 5.5 million candlepower light, making it one of the tallest and most well-lit lighthouses on the east coast of The United States and provides an outstanding view in all directions. The lighthouse is open for tours on a very limited basis conducted by the Hillsboro Lighthouse Preservation Society.

Unique to the Town is that it has only one road running north-south for the entire length of the Town. Travelers will see views of large estate homes and beachside condominiums. The Town is almost exclusively residential. There are approximately 50 single-family residences, and the remaining residents live in condominiums. There is only one hotel for visitors and there are no commercial properties within the Town. The Town takes pride in the protection of its high concentration of turtle nests during the nesting season. At the south end of Town is the Hillsboro Inlet which provides safe navigational passage for boats crossing between the Intracoastal Waterway and the Atlantic Ocean. Located within the Hillsboro Inlet is a marina containing an extensive fleet of charter boats available for excellent daily deep water fishing trips and other marine excursions.

The Town's official population is approximately 2,000, although the population increases significantly in the winter months as property owners return to seasonally occupy their residences.

TOWN OF LAUDERDALE-BY-THE-SEA

Relax...You're Here!



The Town of Lauderdale-By-The-Sea is a small seaside village with more than two miles of beautiful sandy beaches and an iconic pier that attracts annual visitors from around the world. With its low-rise downtown buildings and mid-century modern architecture, the Town exudes old Florida charm while celebrating its present-day connection to the ocean. Located just north of Fort Lauderdale, the Town's hotels, restaurants, stores and ice cream shops are all within a few short blocks. With free live music events every Friday night between November and May, the Town's downtown oceanfront center attracts

hundreds of residents and tourists. Because of its near-shore coral reefs and popularity with scuba divers, Lauderdale-By-The-Sea is "Florida's Beach Diving Capital." It is also home to SS Copenhagen, a 19th Century British steamship that wrecked off the Town in 1900. The shipwreck is not only the most-visited Florida Underwater Archaeological Preserve in the state, it is also listed on the National Register of Historic Places. The Town's annual Christmas-By-The-Sea celebration is one of South Florida's most popular holiday events, attracting 7,000 people in December 2017.

CITY OF LAUDERDALE LAKES We Care



The City of Lauderdale Lakes was incorporated on June 22, 1961. The City comprises an area of approximately four square miles in Broward County, with its center at the crossroads of State Road 7/U.S. 441 and Oakland Park Boulevard.

At the time of incorporation, there were approximately 300 residents in the area. The physical appearance of the city was vastly different than it is today. State Road 7, then a twolane undivided road, was the main thoroughfare through the City. The community was predominantly rural, with most of the land used for farming and grazing. In the early days, the City's only fire truck was staffed by five volunteers, and the "fire station" was nothing more than a parking lot on State Road 7. The first city hall was located in a construction trailer on a development site.

Today, Lauderdale Lakes has more than 35,000 residents of a variety of ethnicities, many of Caribbean descent that reside in the community. The City of Lauderdale Lakes has operated as a Mayor/City Commission/ City Manager form of government. 

TOWN OF SOUTHWEST RANCHES

Preserving Our Rural Lifestyle



The Town of Southwest Ranches is approximately 13 square miles, located in Southwest Broward County, and home to almost 7,500 residents. The Town is a rural environment, filled with grazing animals, nurseries, farms, exquisite and unique scenery and an abundance of wildlife.

The zoning in the Town is almost entirely rural residential and agricultural. We also have a growing amount of zoning for recreation and open space, which preserves land for residents' enjoyment. The newest zoning district is for community facilities that serve the community.

Southwest Ranches was formed to stop encroaching development, and "Preserve Our Rural Lifestyle," which includes donkeys braying, roosters crowing, and no sidewalks. In the fall of 1996, a proposed bill was introduced to the Broward County Legislative Delegation requesting to annex all the unincorporated area between Griffin Road to the north, Sheridan Street to the south, Flamingo Road to the east and SR 27 to the west, known today as Southwest Ranches.

Hundreds of citizens from the Southwest Ranches area called for the right to form their own city. As a result of this grassroots effort, the State Legislature passed a bill in the 1997 session calling for a vote of the citizens of Southwest Ranches in March of 2000.

On July 3, 1999, many of the Southwest Ranches homeowners associations sponsored a parade and picnic to declare the area's independence. Many local, state and federal representatives spoke at the event, which was a huge success!

Many of the Southwest Ranches Homeowners Association members voted to move forward and request a local bill to allow incorporation in 2000 instead of 2001. The bill was approved by the Legislature.

On March 14, 2000, residents voted overwhelmingly to form a new town rather than to be annexed. The next step for a new city would be the creation of its charter. The charter was to be drawn up and an election forming the city held in 2001. However, leaders realized that if a charter could be drawn up sooner, it could possibly be approved as early as 2000. A charter committee was formed to draw up a city charter. The committee met almost weekly during July and in August 1999, formulated a new charter. On June 6, 2000, the charter was approved by the residents and the city became one of thirty municipalities. Council members were elected on July 25, 2000, and the Town was officially in business.

The City of Sunrise is one of South Florida's economic powerhouses, built on a foundation of business, tourism, and entertainment. It's a diverse suburban/urban community with an estimated population of more than 93,000 – a number that's expected to increase substantially over the next 20 years. Sunrise is home to Sawgrass Mills mall - the second-most popular tourist attraction in Florida after Disney World. Another significant asset is the 20,000-seat BB&T Center. This county-owned arena is the home of the Florida Panthers of the National Hockey League, and one of the top ten indoor concert venues in the nation.

The largest office park in South Florida, the 600-acre Sawgrass International Corporate Park, is also situated in Sunrise. The corporate park has significant industry clusters in healthcare, insurance, technology, biomedical, and financial services. And it's just across from American Express' newly constructed 400,000square-foot regional headquarters, which houses 3,200 employees.

In addition to attracting high-profile corporate headquarters, Sunrise is the site of several emerging mixed-use developments. The 50-acre Metropica development will feature some of the tallest structures in western Broward, including a 28-story condominium tower. In addition to 20 acres of condominium/residential development, the project will feature 20 acres of commercial retail, including restaurants, entertainment venues, upscale retail, and a hotel. The adjacent 10 acres will be devoted to Class A office space. In addition, plans for Westerra, a 32-acre mixed-use project that also aligns with the City's live-work-play philosophy, is moving forward.

The City is also committed to investing in its own facilities and infrastructure. In 2014, Sunrise voters overwhelmingly approved general obligation bonds for the purpose of enhancing, improving and developing parks and recreation amenities. Construction of several of these leisure services projects began in 2017, and many more are in design. Additional plans call for the construction of a new city hall that will completely reshape Sunrise's municipal campus.

Whether it's facilitating the expansion of its business sector or providing services and amenities that enhance residents' quality of life, Sunrise is committed to and proud of its vision for the community.

CITY OF TAMARAC *The City For Your Life*




