Message from the President



It is an honor and a privilege to serve as your 2020-2021 President of the Broward League of Cities. With diverse cultures, landscapes, attributes and economic engines, each of our 31 cities offer unique perspectives to the governance of our County and the League's membership. As I began to think about my presidency, I knew it would center around bringing each of these distinctive personalities together through inclusiveness, practiced listening, and collaboration.

This year's theme of "We Are ONE Broward" is a true embodiment of this approach as we work together to address the issues that matter most to Broward County residents. I would like to take a moment now to highlight a few key initiatives that I believe are crucial to our shared growth.

First, COVID-19. Since the early part of 2020, Broward County has been faced with an unprecedented challenge. The far-reaching effects of the COVID-19 pandemic and the resulting closures of businesses and public spaces have permeated every aspect of our lives. As municipal and business leaders, we have a responsibility to move forward from this critical moment in a way that balances action with caution. How do we do this? We do so together. Communication and collaboration will be key to our ability to meet the needs of our communities as we navigate this new world sustainably.

From public transportation and utilities, to the processing of solid waste and recycling, county-wide infrastructure remains a central focus of all our municipalities. In my acceptance speech, I alluded to Aesop's Fable of the Bundle of Sticks. The theme of this fable is one that I intend to keep central to my presidency: we are stronger together. I have no doubt that by focusing on our shared interests through inclusivity, listening, and collaborative goal setting, Broward County will move into the second half of 2020 with purpose. We are, after all, One Broward, and I look forward to seeing what we can accomplish together this year.
