Aaron Tauber: It doesn't provide any incentives to reduce volume of waste, since it would be a flat fee amongst all of the all of the users residential residential customers would pay the same commercial customers would pay, you know likely based on square footage.

Aaron Tauber: It also may not work as well for potential revenue producing waste streams, for example, recyclables for recyclables are generating revenue at it wouldn't really matter what.
